Reservations are subject to the following conditions: (Please read carefully)

1. A campsite can be occupied by only: a) one family consisting of father and/or mother and unmarried minor children; or b) one group consisting of not more than 4 unrelated persons (18 years of age or older).
2. Confirmation date is non transferable.
3. A separate application must be submitted for each campsite.
4. Applications must be received by the park office at least 7 days prior to desired camping date. Incomplete forms and/or incorrect fees will be returned.
5. There is no refund of the first night's camping fee if canceled less than 3 days prior to the date of arrival.
6. The reservation fee is non-refundable unless the campground is closed by the Department of Natural Resources.
7. Your reservation will be held until 3 p.m. of the day following the 1st nights reservation. If there is a "no show" at that time, the entire reservation will be canceled.
8. The Department reserves the right to make adjustments in the assignment of sites as necessary. Fees are subject to change.
9. No check in prior to 3 pm (if site is occupied).
10. A site may be reserved for maximum of 14 nights; Memorial Day, Fourth of July, and Labor Day weekends must be made for 3 nights.
11. Reservations are accepted by mail beginning on the first working day in January each year. February 1, you may apply by mail, in person ,or by telephone(with a credit card). **Phone reservations are taken Monday thru Friday 8 am - 4 pm only, closed on holidays**
